Eastern Oregon University (EOU)	<p>Programs excluded from the staff fee privilege at EOU: EOU excludes all courses offered online, all onsite courses conducted at locations other than on the La Grande campus, and all courses offered as a part of summer term. Exceptions may be granted by the Dean of the College through which the specific course is offered.</p>
