

**STAFF FEE PRIVILEGES and  
TRANSFERRED STAFF FEE PRIVILEGES**

UNIVERSITY	EXCLUDED PROGRAMS
Eastern Oregon University (EOU)	"EOU excludes all courses offered through its Division of Distance Education or at sites other than the La Grande campus and all courses offered as part of the summer term. Exceptions may be approved by the Provost when space is available and full costs for the course have been covered by other enrollments."
Oregon Institute of Technology (OIT)	Programs excluded for staff fee privileges at OIT include: <ol style="list-style-type: none"> <li>1. High School Transition Program</li> <li>2. Advanced College Placement</li> <li>3. Dental Hygiene Program offered in LaGrande</li> </ol>
Oregon State University (OSU)	The following programs are excluded for staff fee privileges at OSU: <ol style="list-style-type: none"> <li>1. Veterinary medicine</li> <li>2. Pharmacy</li> <li>3. OSU Extended Campus online and distance courses</li> </ol>
Portland State University (PSU)	Programs excluded from the staff fee privileges at PSU: <b>All self-support courses including, but not limited to:</b> <ol style="list-style-type: none"> <li>1. Independent Study courses/programs offered by the School of Extended Studies</li> <li>2. Online Masters in Business Administration (eMBA) program</li> <li>3. Haystack courses/programs offered through the School of Extended Studies in Cannon Beach</li> <li>4. Masters of International Management (MIM) courses/program</li> <li>5. Systems Engineering courses/program</li> <li>6. Executive Master of Public Administration (EMPA) courses/program</li> <li>7. On-Line Criminal Justice courses/program</li> </ol>
Southern Oregon University (SOU)	The following are exceptions where enrollment privileges may not be used: <ol style="list-style-type: none"> <li>1. Classes listed in the SOU schedule that are footnoted "This course is not eligible for staff rates."</li> <li>2. Classes sponsored by a school district, agency, or organization</li> <li>3. High School/College Programs (Advanced Southern Credit, Early Entry)</li> </ol>
University of Oregon (UO)	Programs excluded from the staff fee privileges at the UO: <ol style="list-style-type: none"> <li>1. Self-support courses</li> <li>2. Law--Appropriate Dispute Resolution</li> <li>3. Law--Environmental and Natural Resources</li> <li>4. All Portland Programs</li> </ol>
Western Oregon University (WOU)	Staff fee tuition rates do not apply to self-support courses.
Oregon University System (OUS)	Exchange/Study Abroad Programs International Internships (IE3)
Oregon Health & Sciences Univ. (OHSU)	Oregon University System employees are not eligible for reduced tuition on programs offered by OHSU at OUS campuses.

Note: This list is a general summary of excluded courses. Campuses individually determine which courses qualify for staff fees privileges. In the event that periodic changes or updates are not reflected here, the institution's internally published list applies.
