### **JBAC Student Transfer Committee**

---

The **Student Transfer Committee** is an action-oriented standing committee appointed by, and acting on behalf of, the Joint Boards Articulation Commission (JBAC). The JBAC is able, by virtue of their charge from the Joint Boards of Education, to create standing and ad hoc committees to address special issues and topics as needs arise. The Student Transfer Committee is chaired by a JBAC member and takes its direction from the deliberations of the JBAC. Tasks assigned to the Student Transfer Committee have included the following:

- Reviewing the use of the AA/OT, including: clarifying the meaning of block transfer and how the AA/OT will be handled during transfer evaluations at OUS institutions.
- Improving the quality of communication regarding student transfer by providing up-to-date information and documents, including: (1) an "[Articulation Hotline](#)" [list](#); (2) on-line academic advising; (3) electronic transmission of student transcripts; and (4) a directory of OUS web pages dedicated to transfer equivalency.
- Revising the AA/OT degree to reflect K-16 educational reform changes.
- Continuing to develop inter-sector data exchange protocol to better analyze and report on transfer student characteristics and movement patterns; using transfer data to support student transfer policies; and standardizing procedures for sharing student data between community colleges and OUS institutions.
- Examining the feasibility of an Associate of Science/Oregon Transfer degree in Business. Proposing a prototype for such a degree.
